Category One Case - \$387.50-Contracts, torts, personal injury, property damage, malpractice, wrongful death, employment discrimination, civil rights, tax disputes, Conservatorship, special remedies and cases not otherwise specified. **W/O Service \$335.50**

Category Two Cases - \$312.50 -Workers Comp cases (bond may be used); appeals to circuit from general sessions, city courts and other courts or hearings; transfers from foreign counties; writs of mandamus; condemnation/inverse condemnation & quo warranto actions. **W/O Service \$260.50**

Category Three Cases-\$212.50 - Adoptions, legitimations, paternity cases, termination of parental rights, & other domestic relations matters not otherwise designated, name changes, minor settlements, enforcement of foreign judgments & orders of protection (fees not required in advance), cross filings and counter complaints. **W/O Service \$160.50**

Category Four Cases – \$187.50 – Child Support enforcement and modification, interstate support cases, modification of parenting plan, civil contempt. **W/O Service 135.50**
